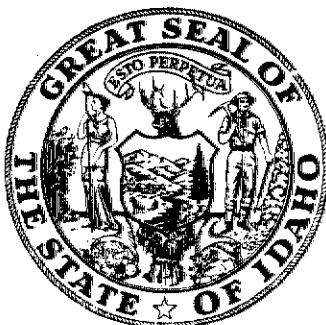

The following Articles of Incorporation are hereby adopted pursuant to the Idaho Business Corporation Act:

**1. Name.**

The name of the corporation is:

**2. Duration.**

The corporation shall have perpetual duration.

**3. Purposes.**
