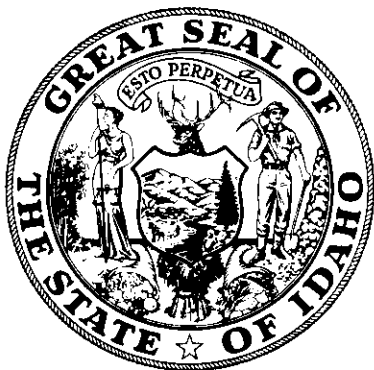

ARTICLES OF CORPORATION

OF

GATEWAY SCHOOL, INC.

KNOW ALL MEN BY THESE PREMISES, that we, the undersigned, being natural persons of full age and citizens of the United States of America, in order to form a corporation for the purposes hereinafter stated, under and pursuant to the provisions of the general corporation laws of the State of Idaho and the acts amendatory thereof and supplemental thereto, do hereby certify as follows:

FIRST

The name of this corporation is Gateway School, Inc.

SECOND

Gateway School, Inc. is a non-profit corporation.

THIRD

The duration of the corporation is perpetual.

FOURTH

The purpose of the corporation is to provide a proper education to the children of ROGER and JERI ADAMS, and to conduct any other lawful activities which may from time to time be deemed appropriate by the directors.

FIFTH

The corporation shall have members, and management of the corporation shall be vested in the members of the Board of Directors. The initial Board of Directors shall select subsequent members and directors.

SIXTH

The corporation is not a church.

SEVENTH

The internal affairs of the corporation shall be regulated by the officers, subject to the control and direction of the Board of Directors.

EIGHTH

NINTH
