ARTICLES OF AMENDMENT TO
ARTICLES OF INCORPORATION OF
D. & S. PURPLE SAGE RANCHETTE
WATER ASSOCIATION INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, the President and Secretary respectively of D. & S. PURPLE SAGE RANCHETTE WATER ASSOCIATION INC., an Idaho corporation, do hereby certify as follows:

That D. & S. PURPLE SAGE RANCHETTE WATER ASSOCIATION INC. is a corporation duly organized and existing under and by virtue of the laws of the State of Idaho;

That at the Annual Meeting of the Shareholders of D. & S. PURPLE SAGE RANCHETTE WATER ASSOCIATION INC. held on the 27th day of January, 1979, at the hour of 7:30 o'clock p.m. of said day, at the Middleton High School, Middleton, Idaho, at which said meeting a majority of the Shareholders of said corporation were present, a Resolution was regularly proposed, voted upon and adopted by a majority vote of all of said Shareholders amending the Articles of Incorporation of said corporation, and that the following is a full, true and correct copy of the Resolution of said Shareholders amending the Articles of Incorporation of said corporation, to-wit:

RESOLUTION

BE IT RESOLVED, That the Articles of Incorporation of D. & S. Purple Sage Ranchette Water Association Inc. be and the same are hereby amended as follows:

Article VII is hereby amended to read in its entirety as follows:

" ARTICLE VII

The affairs of the corporation shall be managed by a Board of Directors which shall consist of three (3) Directors, all of whom shall be members in good standing of this corporation. The Directors shall manage the affairs of this corporation according to the By-Laws. The Board of Directors shall elect a President, one or more Vice-Presidents, a Secretary and a Treasurer, which offices may be combined, any one of which may be members of the Board of Directors, and may also provide for the appointment of such other officers and agents as they may deem necessary to conduct the business of the corporation. This corporate association shall be governed by a code of By-Laws not inconsistent with the laws of the State of Idaho, and amendments thereto, which said By-Laws shall be adopted and amended by the members of this corporation. The By-Laws shall fix and regulate, among other things, the conditions for the right, nature and extent of the use of the water. The Board of Directors shall recommend to the Shareholders the rate to be charged by the association to the Shareholders for delivery of water by the association, which rate shall be effective when approved by a majority of the Shareholders at any Annual or Special Meeting called for that purpose. Such charge shall not be deemed an assessment or lien upon the land absence operation of a court of law, but shall be the obligation of the individual Shareholder. "

That said Resolution of the Shareholders was approved on the 27th day of January, 1979, by a majority vote of the Shareholders of said corporation.
