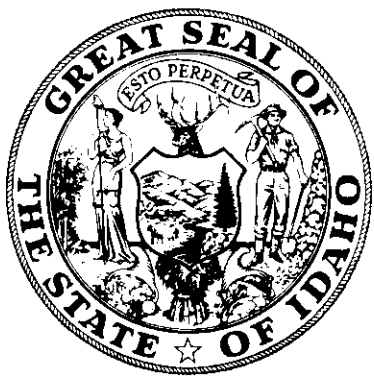

ARTICLES OF INCORPORATION

OF

M & F, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporations Act, adopt the following articles of incorporation for such corporation:

FIRST:

The name of the corporation shall be M & F, Inc.

SECOND:

The period of duration of the corporation is intended to be perpetual.

THIRD:

The purpose or purposes for which the corporation is organized are: To acquire, build upon, develop, landscape, lease, sell, and purchase, real property. In addition, the corporation may engage in the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH:

The aggregate number of shares which the corporation shall have authority to issue is five hundred (500). There shall be one class of shares and all of such shares are to be without par value. The stated capital of the corporation is the sum of fifteen thousand dollars (\$15,000.00).

FIFTH:

The address of the initial registered office of the corporation is 1544 Clairview Lane, Idaho Falls, Idaho 83402, and the name of its initial registered agent at such address is O. Gene Forbes.

SIXTH:

The number of directors constituting the initial board of directors of the corporation is two (2), and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:


