SECOND ARTICLES OF AMENDMENT of the Articles of Incorporation of Agri Beef Co. are hereby executed by said Corporation as follows:

- 1. The name of the Corporation is Agri Beef Co.
- 2. The amendment to the Articles of Incorporation of said Corporation is the following:

Article VII thereof is deleted and the following is substituted thereof:

VII.

The aggregate number of shares which the corporation shall have authority to issue is five million, one hundred and fifty thousand (5,150,000) shares, of which five million (5,000,000) shares of no par value per share shall be designated non-voting common shares and one hundred and fifty thousand (150,000) shares of no par value per share shall be designated voting common shares.

Each share of voting common stock shall have the same rights, privileges and voting power and each share of non-voting common stock shall have the same rights and privileges as of both voting and other share and shall be non-voting common stock non-assessable, except that shares of

non-voting common stock shall not be entitled to vote.

- 3. The date of the adoption of said amendment by the shareholders of the Corporation was September 27, 2000.
- 4. The number of shares of Agri Beef Co. outstanding is one hundred thousand, eight hundred and seven (100,807) shares of common stock. All of those shares were entitled to vote on the amendment.
