

CERTIFICATE OF INCORPORATION.

ARTICLES OF INCORPORATION OF THE STAR POTTERY COMPANY
LIMITED.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a corporation, under the laws of the State of Idaho.

AND WE HEREBY CERTIFY:

FIRST:- That the name of the said corporation is the Star Pottery Company, Limited.

SECOND:- That the purposes for which it is formed are to manufacture all classes of pottery ware, and to sell the same at wholesale and retail; to buy, sell and own such real estate and personal property as may be necessary for the purpose of carrying on the business of the company to the best advantage, and to do all things necessary and incident to the manufacture and sale of pottery ware.

THIRD:- That the place where its principal business is to be transacted shall be the town of Shelley, Bingham County, Idaho.

FOURTH:- That the term for which it is to exist is fifty years from and after the date of its incorporation.
