We, the undersigned residents of the State of Idaho, being 18 years or more of age, do hereby associate ourselves together for the purpose of forming a nonprofit corporation under the statutes of the State of Idaho.

ARTICLE ONE

The name of the corporation shall be PARIS CITY HISTORICAL MUSEUM ASSOCIATION INC. and its location shall be 34 S. Main, City of Paris, County of Bear Lake, State of Idaho.

ARTICLE TWO

This corporation shall be a nonprofit corporation.

ARTICLE THREE

The period of duration of this nonprofit corporation shall be perpetual

ARTICLE FOUR

The business and purpose of this nonprofit corporation shall be to discover and memorialize the history of the town of Paris, Idaho and the surrounding area in the County of Bear Lake; to discover, purchase, commission, or otherwise procure, and to publish or otherwise preserve writings, newspapers, journals, and the like, which shed light on the history of the region; to discover, procure, and preserve physical objects that may relate to the history of the region; to establish and maintain a museum on land leased or owned by the society; and to hold regular meetings and other activities for the recreation and

instruction of the members; and to receive and maintain funds and to apply the income and principal to promote the foregoing purposes.

ARTICLE FIVE

The corporation shall be nonstock, and no dividends or pecuniary profits shall be declared or paid to the members thereof.

ARTICLE SIX
