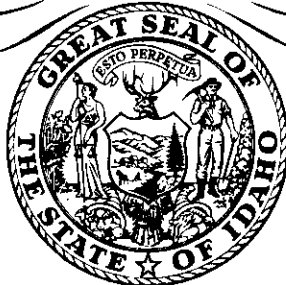

I, ARNOLD WILLIAMS, Secretary of State of the State of Idaho, and legal custodian of the corporation records of the State of Idaho, do hereby certify that the original of the articles of incorporation of **TREASURE VALLEY CHAPTER 103 OF THE EXPERIMENTAL AIRCRAFT ASSOCIATION, INC.**

was filed in the office of the Secretary of State on the **fourteenth** day of **August** **sixty-seven** and will be **microfilm** A. D. One Thousand Nine Hundred **and** is duly recorded on Film No. of Record of Domestic Corporations, of the State of Idaho, and that the said articles contain the statement of facts required by Section 30-103 and Sections 30-1001 to 30-1005, inclusive, Idaho Code.

I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name hereinbefore stated, for **Perpetual Existence** from the date hereof, with its registered office in this State located at **Boise, Idaho** in the County of and as such are subject to the rights, privileges and limitations granted to Non-Profit Cooperative Associations as provided in Chapter 10, Title 30, Idaho Code.

ARTICLES OF INCORPORATION

We, the undersigned, being U. S. citizens of legal age, have associated ourselves together and do form a corporation as follows:

Art. I

The name of the corporation shall be: "Treasure Valley Chapter 103 of The Experimental Aircraft Association, Inc."

Art. II

The principal place of business of the corporation shall be Meridian, Idaho.  
The mailing address will be, P. O. Box 597, Meridian, Idaho, 83642.

Art. III

The purposes for which this corporation is formed are:

- (a) To encourage, aid and engage in scientific research for the improvement and better understanding of aviation and the science of aeronautics.
- (b) To foster, promote and engage in aviation education.

Art. IV

This corporation shall not operate for profit; however if it should have earnings, no part of such earnings shall inure to the benefit of a member or any other individual.

Art. V

Each membership in this corporation will be evidenced by one certificate of membership which will not be transferable. The rights and interests of all members shall be equal, and no member can acquire a greater interest therein than any other member.

Art. VI

It is contemplated that the existence of this corporation will be perpetual. However, in the event of dissolution, any assets that might then be owned by the corporation shall be distributed only to some other corporation, to be designated by the Board of Directors, which is exempt from taxation under section 501(c)(3), Internal Revenue Code (1954)
