The undersigned hereby states the following to form a corporation under the laws of the State of Idaho:

1. The name of the corporation is Coastal Borders, Inc.
2. The corporation shall have perpetual duration.

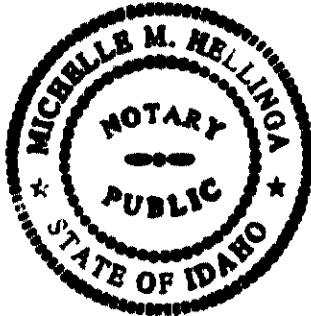
