

Know All Men By These Presents: That we the undersigned do hereby associate ourselves together for the purpose of forming a corporation under the laws of the State of Idaho and we declare as follows, to-wit:

1.
The name of this corporation shall be the
Carr Creek Irrigation Company.

2.

The purposes for which this corporation is formed are as follows: (a) buying and selling and acquiring by appropriation water rights, reservoirs, ditches and canals and rights-of-way for same, holding water rights, reservoir sites, ditches and canals for the purpose of sale and distribution of water and water rights and all appurtenances thereto; (b) the buying

and selling of lands; (c) the irrigation of farming lands and farming of same; (d) and to do any and all things necessary and proper to be done with reference to the carrying out of the aforesaid purposes.

3.

The place where its principal business is to be transacted is Hill City, Blaine County, Idaho, but meetings of the directors of this corporation may be held at any place outside of the State of Idaho as the directors shall designate.

4.

The term for which this corporation shall exist is fifty years.

5.

The number of its directors shall be three.

6.

The amount of its capital stock is \$45,000.00.

and the number of shares into which the capital stock is divided is 3,000 and the par value fifteen (\$15.00) dollars. The amount of capital stock actually subscribed is as follows:
