FIRST. The name of this corporation shall be:

WEISER WOMEN'S BOWLING ASSOCIATION, INC.

SECOND. Its registered office in the State of Idaho is to be located at 1500 West Seventh Street in the City of Weiser, County of Washington and its registered agent at such address is Kristie Hayes.

THIRD. The purpose of this corporation shall be:

In furtherance of the foregoing objects, this association shall be conducted as a non-profit association, organized and operated at all times exclusively for charitable and educational purposes and, particularly, to foster regional, national and international bowling competition either directly or by contributions to organizations that are recognized as exempt from federal income taxation as organizations described in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended. In furtherance of the foregoing purposes, this association shall be organized and operated primarily to conduct or support bowling athletes for national or international competition with the meaning of Section 501(j)(2) of the Internal Revenue Code of 1986, as amended.

FOURTH. The period of existence and duration of the life of this corporation shall be perpetual.

FIFTH. The non-profit corporation shall have no stock, however, the corporation shall have voting members as evidenced by membership in good standing under a sanctioned league of Head Pin Lanes by the Women's International Bowling Congress.

The first Board of Directors shall consist of five (5) directors, but during their term of office, or thereafter, the number of directors may be increased or decreased from time to time as may be provided by the by-laws; provided, however, that the number of directors constituting a Board shall not be less than three (3). NINTH. Dissolution: In the event that the Corporation shall be liquidated and dissolved, all of its assets remaining after payment and discharge of its duties, obligations and liabilities shall be distributed, in such proportion as the Board of Directors shall determine, to any organized and operated exclusively for charitable and educational purposes, provided that no portion of the assets shall be distributed to any organization that is not described in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended. Any such assets not so disposed of shall be disposed of by the Circuit Court in which the principal office of the Corporation is then located, exclusively for the purposes described in Section 501(c)(3) of the Internal Revenue Code of 1986, as amended, or to such organization or organizations as said Court shall determine are organized and operated exclusively for such purposes.
