on their respective oath does depose and say as follows:

That the said Henry Dixon is the Chairman of the Board of Trustees of the Church of Christ - Christian, Inc., and the said Marydell Hiemstra is the secretary of the Board of Trustees of the Church of Christ - Christian, Inc.

That there is attached hereto a Written Assent of Amendment of Articles of Incorporation to Add an Additional Section, which will be Section Eight, which document was signed and executed by members of the corporation representing in excess of two-thirds of the actual members of the corporation, and the affiants hereto, having access to the books and records and membership roll of the said corporation, do hereby aver that the members of the corporation signing the said written assent do exceed in number two-thirds of the total membership of the said corporation.

That the amendment does consist of the addition of an Eighth Section to the Articles of Incorporation of said corporation, as amended, so that the said Eighth Section does read in its entirety as follows, to-wit:

"EIGHTH
