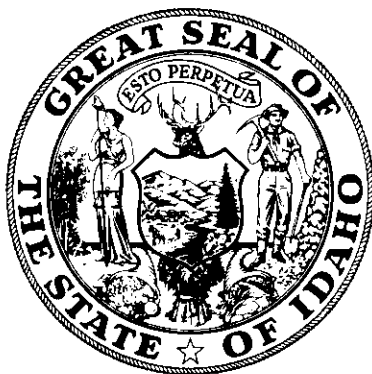

ARTICLES OF INCORPORATION  
OF  
VICTORY BIBLE CHURCH, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Nonprofit Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of this corporation, as incorporated under the laws of the State of Idaho, shall be VICTORY BIBLE CHURCH, INC.

ARTICLE II

VICTORY BIBLE CHURCH, INC., is a non-profit corporation. All money received and used for operating expenses will be derived from tithes and offerings of its members and friends.

ARTICLE III

It is our desire and intent for this religious, non-profit corporation to continue without end.

ARTICLE IV

The purpose of this corporation is:

1. To preach the Gospel of Jesus Christ;
2. To teach His Word to those who trust Him; and
3. To provide a place of fellowship for His

followers.

ARTICLE V

The corporation shall consist of believers in Jesus Christ who agree with our doctrine and purpose for existing. They must request membership and be accepted by the other members present. The management of the affairs of this corporation shall be vested in its members.

ARTICLE VI

The corporation will not have a board of directors, however its officers shall consist of: President (Pastor),


