DECREE OF DISSOLUTION

The voluntary application for dissolution of the Hayden Lake Honeysuckle Hills, Inc., a corporation, organized and existing under and by virtue of the laws of the State of Idaho, coming on regularly this day for hearing and determination,
THE COURT FINDS:

That on April 2d, 1948, in accordance with the order of this Court, the said Hayden Lake Honeysuckle Hills, Inc., filed with the Clerk of this Court its application for dissolution as a corporation; that said application was in all respects in accordance with the laws of this State.

THE COURT FURTHER FINDS that in accordance with the order of this Court, the Clerk of this Court has given thirty days notice of said application for dissolution by publication in the Coeur d'Alene Press, a newspaper of general circulation printed and published in the County of Kootenai, State of Idaho, and that the notice so published by said Clerk contained all information necessary and requisite and in accordance with the laws of this State.

THE COURT FURTHER FINDS THAT no objections to said application for dissolution has at any time been made or filed herein.

THE COURT FURTHER FINDS, after hearing and considering the evidence introduced in support of such petition, that all allegations and statements in said application for dissolution made are true and that the petitioners are entitled to a decree of this Court as prayed for in said petition.

IT IS, THEREFORE, HEREBY ORDERED, ADJUDGED AND DECREED that the said corporation, the Hayden Lake Honeysuckle Hills, Inc., a corporation organized under the laws of the State of Idaho, be and the same hereby is declared, adjudged and decreed to be dissolved and no longer in existence for any purpose whatsoever.
