ARTICLES OF INCORPORATION
of
"MEDICAL CLINIC, INC."

KNOW ALL MEN BY THESE PRESENTS that we, the undersigned, E. R. W. FOX, WILLIAM T. WOOD and W. WRAY WILSON and J. RICHARD OLESBERG, of Coeur d'Alene, Idaho, and all of whom are bona fide residents and citizens of said State and of legal age, have this day voluntarily associated ourselves together for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, and we do hereby certify:

I.

That the name of this corporation shall be
"MEDICAL CLINIC, INC.".

II.

That the duration and existence of this corporation shall be perpetual.

III.

The purposes for which this corporation is formed are as follows:

In addition to the corporate powers as provided by the Statutes of the State of Idaho, to acquire, own, maintain and operate a medical office building for the use of its shareholders and others; to lease, operate and manage medical buildings, pharmacies, laboratories, and other allied businesses, and to own and/or lease real estate, buildings, structures, and structural equipment for operating pharmacies, laboratories and medical buildings, and to do all things necessary and proper in

running and operating such businesses, and to transact all other business requisite to carrying out the general purposes of this corporation and to do all acts permitted by the General Business Corporation Law of the State of Idaho, and all such other acts as are necessary and expedient to accomplish these stated purposes.

IV.

That the location of the office will be:

Coeur d'Alene, Idaho.

V.

That the total authorized stock of this corporation shall be \$100,000.00 divided into 1,000 shares of the par value of \$100.00 each.

VI.

That the only authorized stock shall be the common stock of said corporation with equal rights, preferences and restrictions.

IX.

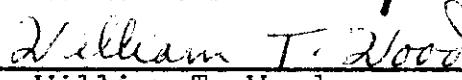
The By-Laws of this corporation shall be adopted by the

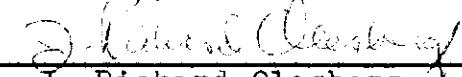

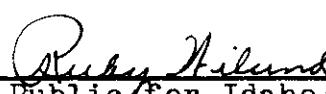
