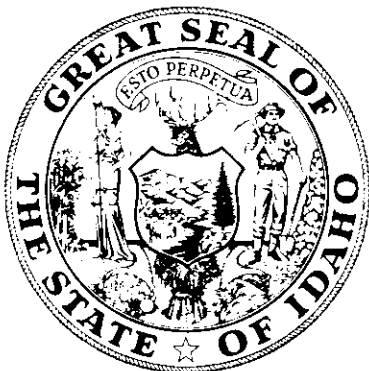

5. DISTRIBUTION OF ASSETS: All of the remaining property and assets of the corporation have been distributed between the shareholders in proportion to their respective holdings.


