We, the undersigned, natural persons over the age of eighteen years and citizens of the United States, do this day voluntarily form a service corporation under the laws of the State of Idaho, as contained in Chapter 1 of Title 30, <u>Idaho Code</u>, entitled "General Business Corporation Act" and to that end we certify in writing:

ARTICLE I NAME

The name of the corporation shall be ROWDY, INC.

ARTICLE II PURPOSE AND POWERS

The purposes for which this corporation is organized are:

- (a) To engage in the business of establishing and running a restaurant and bar;
- (b) To invest funds in real property, personal property, mortgages, stocks, bonds or any other types of investments and to own or lease real or personal property necessary for the rendering of such business; and

Subject to dissolution in the manner provided by law, the corporation shall be perpetual.

ARTICLE IV REGISTERED OFFICE
