THIS IS TO CERTIFY that we. the undersigned, hereby incorporate pursuant to the Laws of the State of Idaho providing for the formation of corporations for profit, for the purpose and with the powers hereinafter stated.

The general nature of and purpose of this corporation shall be the operation of a vidio tabe and player rental business and the performance of any and all activities generally associated thereto: and also

To engage in any activity or bussiness permitted under the Laws of the United States and of this State.

III

The existance of the corporation is to be perpetual.

The principle place of business of this corporation shall be: 312 South Main Hailey, Idaho 83333 and branch offices may be located in other place as may be designated from time to time.

V

The amount of capital with which this corporation shall commence business shall be no less than Five Hundred Dollars (\$500.00).
