Pursuant to the provisions of Section 30-1-61 of the Idaho Business Corporation Act, the undersigned corporation adopts the following Articles of Amendment of its Articles of Incorporation:

FIRST: The name of the Corporation is CTP, INC.

SECOND: The following amendments of the Articles of Incorporation were adopted by unanimous consent of the Board of Directors of said Corporation on the 17th day of January, 1996, in the manner prescribed by the Idaho Business Corporation Act:

The Articles of Incorporation of said Corporation are amended as follows:

Add a new Article X, which shall state as follows:

"These Articles of Incorporation may not be amended, by the shareholders, the board of directors, or otherwise, except with the unanimous approval of the Board of Directors (including the Independent Director).

Add a new Article XI, which shall state as follows:

"If any provision of these Articles of Incorporation is determined to be unenforceable or contrary to law, the remaining provisions shall be deemed severable therefrom and shall remain in full force and effect."

THIRD: There were no shares of the corporation outstanding at the time of such adoption.


