The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is D AND D WIEBE, INC.

SECOND: The period of this corporation's duration shall be perpetual from and after the date of the filing of these Articles of Incorporation with the Idaho Secretary of State's Office.

THIRD: The purposes for which the corporation is organized are the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is five thousand (5,000) shares, with a par value of One Dollar (\$1.00) per share.

FIFTH: There are no provisions denying pre-emptive rights.

SIXTH: The internal affairs of the corporation shall be governed by a duly adopted Code of Bylaws which shall be consistent with these Articles of Incorporation and the laws of the State of Idaho.

SEVENTH: The address of the initial registered office of the corporation is Route 6 Box 25, Priest River, Idaho 83856, which office is physically located on the East Side Road, north of the municipality of Priest River in rural Bonner County Idaho. The name of the registered agent at such address is DIANNE A. WIEBE.


