ARTICLES OF AMENDMENT

(Nonprofit Corporation)

GREATER POCATELLO SENIOR CITIZENS, INC.

Amendment of the Articles of Incorporation of Greater Pocatello Senior Citizens, Inc., a nonprofit corporation organized under the laws of the State of Idaho (I.C. §30-301 et seq.), executed by the incorporators, acting as the initial Board of Directors.

- 1. The corporation was issued a Certificate of Incorporation under the provisions of the Idaho Nonprofit Corporation Act on November 6, 1981.
- 2. The corporation has no members at this time and an initial membership meeting has not been held.
- 3. The undersigned, being the incorporators, and acting as the initial Board of Directors, by a resolution duly adopted by unanimous vote of the full Board of Directors at a meeting on November 23, 1981 do hereby execute and acknowledgethat the following amendment was duly approved by the Board of Directors:

By adding after Article Five the following article:

ARTICLE SIX

PURPOSES

The corporation is organized, and operated exclusively for charitable, benevolent and educational purposes. The corporation shall attempt to reduce the extent of poverty and to alleviate the effects of poverty on the elderly poor; to help all senior citizens to achieve their maximum potential for independent living; and to receive donations, contributions, grants and matching funds from any person, firm, corporation, government agency or other source to carry out the purposes of the corporation.
