## ARTICLES OF INCORPORATION

PEND OREILLE ARTS TRADITIONS AND HOUSLIFE SKILLS, Inc.

That WE, the undersigned persons, acting as the incorporators of a corporation under the provisions of and in accordance with the Idaho Mon-Profit Corporation Act, 30-301 et seq., and consistent with the provisions of the Internal Revenue Gode Section 501 (c) (3), do hereby form and incorporate ourselves into a voluntary association for the purposes set forth herein and adopt the following Articles of Incorporation for such corporation.

### ARTICLE I: NAME

This corporation shall be known as the Fend .

Oreille Arts Traditions and Homelife Skills, Inc., by which name it shall contract and be contracted with, sue and be sued, and transact all of its business.

# ARTICLE II: NON-PROFIT CORPORATION

The Pend Oreille Arts Traditions and Momelife Skills Corporation shall be a non-profit corporation.

# ARTICLE III: DURATION OF THIS CORPORATION

The period of duration shall be perpetual.

## ARTICLE IV: PUEPOSES

The purposes of this corporation shall be to reserve and establish among folks, those arts, skills, and traditions, which a majority of the membership believes nurtures and strengthens society and insures a healthy environment.

## ARTICLE V: WARFERS

This corporation is to have members and the membersment of its affairs shall be delineated in its by-laws.

#### ARTICLE VI: REGULATION OF INTERNAL APPAIRS

This corporation shall not have power to act except in furtherance of the purposes set forth in ARTICLE IV hereof.
