

ARTICLES OF INCORPORATION

of

DeARMOND BROS. LUMBER CO., INC.

KNOW ALL MEN BY THESE PRESENTS, that the undersigned,
D. E. DeARMOND, R. L. DeARMOND and R. J. DeARMOND, all residents
of the state of Oregon, have this day associated themselves
together for the purpose of forming a private corporation under
the general laws of the state of Oregon, and for that purpose do
hereby make, adopt, execute and acknowledge, in triplicate, the
following

ARTICLES OF INCORPORATION

ARTICLE I

The name of this corporation shall be

DeARMOND BROS. LUMBER CO., INC.

and its duration shall be perpetual.

ARTICLE II

The enterprise, business, pursuit or occupation in which this corporation proposes to engage is as follows:

- (1) To own and operate sawmills, lumber remanufacturing and processing plants and dry kilns, and to buy and sell lumber and timber.
- (2) To purchase, acquire, possess, own, hold, lease, erect, operate and maintain mills and factories for the manufacture and remanufacture of lumber and other wood products, and to engage generally in the manufacturing and disposition of such commodities.
- (3) To engage in the business of logging and to purchase, acquire, possess, deal in, own, hold, enjoy,
 improve, lease, mortgage, contract for the purchase, sale or conveyance of, and to construct, maintain and operate logging roads,

and to use in the operation of such logging roads any motive power that may be found convenient or practicable.

- (4) To engage in the business of moving, storing, booming and rafting logs, and to do and perform any
 and all acts of things necessary and desirable in such business,
 and to make charges for services and privileges in connection with
 such business.
- (5) To purchase, lease and otherwise acquire, and to own, possess, hold, improve, mortgage, sell, convey or otherwise dispose of, real property and personal property; and to own, acquire, buy and sell real estate and any interest of any kind whatsoever therein, and to carry on a general real estate business.
- (6) To subscribe for, purchase or otherwise acquire, and to hold and use with the same rights therein as may be permitted to natural persons, shares of stock, bonds and obligations of any corporation or association, including stock in this corporation, and to mortgage, pledge, hypothecate, sell and generally deal in such shares of stock, bonds and obligations.
- (7) To guarantee contracts and obligations in which this corporation has or may have an interest, direct or indirect, to borrow money for the general or special purposes of this corporation, and to give as evidence thereof bonds, coupon notes, promissory notes or other evidences of indebtedness, and to mortgage, pledge and give or convey in trust any and all of the property, real and personal, of this corporation to secure the payment thereof.
- (8) To endorse, guarantee and secure the payment and satisfaction of the bonds, Coupons, mortgages, deeds of trust, notes, debentures, securities, obligations, evid-dence of indebtedness, and shares of the capital stock of other corporations.

(9) To do and perform any other act, matter or thing necessary, proper or convenient for the accomplishment or carrying out of the enterprise, business, pursuit or occupation hereinabove specified.

ARTICLE III

The principal office and place of business of this corporation is Rogue River, in the county of Jackson, state of Oregon.

ARTICLE IV

The capital stock of this corporation shall be \$24,000.00, and shall be divided into 240 shares of the par value of \$100.00 each.
