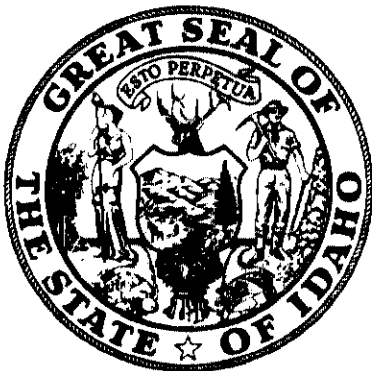

express provisions of the Act under which this corporation is incorporated;

h. The foregoing shall be construed both as objects and powers, and the enumeration thereof shall not be held to limit or restrict, in any manner, the powers conferred on the corporation by the laws of the State of Idaho, all of which are hereby expressly granted;

i. This corporation is organized exclusively for religious, charitable, scientific, literary, or educational purposes within the meaning of Section 501 (c) (3) of the Internal Revenue Code; and

j. Notwithstanding any other provisions of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on by an organization exempt from Federal Income Tax under Section 501 (c) (3) of the Internal Revenue Code.

ARTICLE V: MEMBERS OF CORPORATION. The corporation shall be nonprofit under Title 30, Chapter 3, of the Idaho Code. All members shall sit on the board of directors. It shall be exempt from taxation as contemplated under Section 501 of the Internal Revenue Code (26 U.S. Code) and to have gifts and donations given to the corporation be deductible by the donors as contemplated by Section 170 of the Internal Revenue Code (26 U.S. Code).

ARTICLE VI: DIRECTORS OF CORPORATION. The number of directors constituting the initial board of directors shall be no more than seven. The names and addresses of the board of directors are:

The undersigned Incorporator hereby incorporates ERIC MARTIN'S HOMES FOR KIDS, INC. under the provisions of title 30 of the Idaho Code.

ARTICLE I: CORPORATE NAME. The name of the corporation shall be ERIC MARTIN'S HOMES FOR KIDS, INC.

ARTICLE II: REGISTERED AGENT. The initial authorized agent of ERIC MARTIN'S HOMES FOR KIDS, INC. shall be William F. Masimer whose address is number 1811 Yale Court, Boise, ID 83706.

ARTICLE III: CORPORATE TERM. The corporation shall have a perpetual existence.

ARTICLE IV: CORPORATE PURPOSES. The purposes of this corporation are:

- a. To provide short and long term physical shelter and support to kids with life-controlling problems, while modeling basic Christian values; to assist kids to function in society, applying spiritually motivated Biblical principles to relationships in the family, local church, chosen vocation, and the community; and to endeavor to help kids become physically well, socially adjusted, and spiritually alive;
- b. To promote and provide proper facilities to encourage physical well-being for those needing shelter, and to provide an environment to promote physical, emotional, and social maturity;
- c. To buy, lease, hold, and exercise all privileges of ownership, over such real or personal property as may be necessary or convenient, for the conduct and operation of the business of the corporation, or incidental hereto; and to receive and distribute gifts of property of all kinds;
- d. To carry on all business whatever which this corporation may deem proper or convenient in connection with any of the foregoing purposes of otherwise, or which may be calculated directly, or indirectly, to promote the interest of this corporation, or to enhance the value of its property or business;
- e. To borrow money; to lend money, to own property, to own personal property, to deal in real property; to have, and to exercise, all powers conferred by the laws of the State of Idaho upon corporations formed under the laws pursuant to, and under which, this corporation is formed, as such laws are now in effect or may at any time hereafter be enacted or amended;
- f. To co-operate with similar associations and corporations;
- g. To have and exercise all power, privileges, and rights conferred on corporations by the laws of this state and all other powers and rights incidental to carrying out the purposes for which this corporation is formed, except such as are inconsistent with the
