ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS: That we the undersigned, being natural persons of full age, and citizens of the United States and of the State of Idaho, in order to form a corporation for the purposes hereinafter stated, pursuant to the business corporation act of Idaho, do hereby certify as follows:

1. That the name of the corporation is Sheet Metal Products Company.
2. That the purposes of the corporation are to install and repair hot air heating plants, gas fitting, and apparatus in buildings, and to engage in the business of blanking, drawing, forming, punching, shearing, and tooling sheet metal of all kinds and types, and the fabrication and installation of all types of metal and metal products.
3. The duration of the corporation is perpetual.
4. The Location and Post Office address of the registered office of the said corporation in the State of Idaho is Post Office Box 111, Pocatello, Bannock County, State of Idaho.
5. The total number of par value shares is 100. The aggregate par value of the total authorized number of par value shares is \$5000.00. The stock of the corporation is divided into 100 equal shares of commonstock in the value of \$50.00 each.
6. The stockholders of this corporation shall not be personally responsible for the debts of the corporation unless the specifically and expressly assume the same and in each separate instance by and through the execution personally of a writing so assuming the individual debt in question.
