- 1. That the name of the corporation if Sheet Metal Products Company.
- 2. That the purposes of the corporation are to install and repair hot air heating plants, gas fitting, and apparatus in buildings, and to engage in the business of blanking, drawing, forming, punching, shearing, and tooling sheet metal of all kinds and types, and the fabrication and installation of all types of metal and metal products.
