ARTICLES OF INCORPORATION
OF
WORLDWIDE HIVE CORPORATION

KNOWN BY ALL MEN BY THESE PRESENTS:

That we, the undersigned, being natural persons of full age and citizens of the United States of America, in order to form a corporation for the purposes hereinafter stated, pursuant to the laws of the State of Idaho, under the provisions of Title 30, Chapter 1, Idaho Code, we hereby submit the following Articles of Incorporation:

ARTICLE I

The name of the Corporation shall be:

Worldwide HIVE Corporation.

ARTICLE II

The total number of shares which the Corporation is authorized to issue is 100,000,000 shares. The aggregate par value of said shares is \$1,000,000.00 and the par value of each share is one-cent.

ARTICLE III

The location and post office address of the Corporation's registered office in this state shall be 2300 South Charlotte Drive, Idaho Falls, Idaho 83402. The name of the Corporation's registered agent is Davidjohn Stosich.

ARTICLE IV

The name and post office addresses of the incorporators and the number of shares subscribe by each are as follows; and of the initial directors are as follows:

ARTICLE V

The mailing address of the corporation shall be:

ARTICLE VI

The purposes for which said corporation is formed are:

1. To promote the HIVE principle, of accountability and agency of knowledge, truth and intelligence.
2. To engage in a general worldwide information enterprise of promoting the HIVE principle, to create and exchange databases and indices of all kinds, to index, classify, any and all known kinds of information, to promote, operate, set up and supervise all kinds of centers, systems, networks, organizations for the purpose of providing standards, diagnostics, achievements, educations, certifications, profiles, assessments, remediations, learning, tracking, developments, and in general knowledge and intelligence, involving the use of computers, satellites, video, audio, electronic mediums and media, interfaced devices, beams, light sources, and every imaginable legal means of communication, and to own, sell, distribute, advertise, publish, broadcast, inventory, analyze, share, market and vend all kinds of products from whatever source; and especially those developed, manufactured or created for the purpose of learning, acquiring knowledge and intelligence and development, to help the less fortunate, to

separate the wheat from the chaff, to discern between correct and incorrect, to measure knowledge and intelligences, but not to exclude all other sorts of distribution rights and capabilities; also to own and sell distributorship rights, licensing rights within the states and anywhere legal in the world and to service the same, and to do all things incidental to such business. To create and grant all kinds of awards, standards of achievements, certifications, credentials, and degrees and measurements by HIVE and by any other standard necessary to the purposes of the corporation. . Also, including the operation of retail and/or wholesale business for the purchase and sale of all classes of goods, wares and merchandise, including all things which may be necessarily or conveniently sold or used in any center of learning or achievement. Also, to lease, buy and otherwise acquire real estate, and to lease, sell and dispose of the same, and to do all things subsidiary, necessary or convenient for the carry out and into effect the main purposes and objects of this corporation.

3. To engage in any business related or unrelated to the described in Clause 1. Of this Article and from time to time authorized or approved by the Board of Directors of this corporation.

4. To have and exercise all rights and powers from time to time granted to a corporation by law.

5. To manufacture, own, buy, sell, export, import, and deal in, both at wholesale and retail, all kinds of goods, wares, foods, drugs, merchandise, manufactures, computers, internets, cyberwares, furniture, machinery, instruments, tools, supplies, services, certifications, schools, products and generally to engage in any mercantile, manufacturing, service, construction, or brokerage business of any kind of character not contrary to law, within or without the State of Idaho; to do all things incidental to any such business.

6. To generally engage in the business of buying, selling or otherwise dealing in notes, open accounts, and other similar evidences of debt, and all other forms of real, personal or mixed property chooses in action; to receive and accept transfers, pledges, mortgages, and conditional sales contracts and to deal with the same as owner,

ARTICLE VII

The Corporation is to have a perpetual existence.

ARTICLE VIII

The Board of Directors shall consist of three (3) directors, but during their term of office, or thereafter, the number of directors may be increased or decreased from time to time may be provided by the By-Laws; provided, however, except as provided below the number of directors consisting the Board shall not be less than one nor more than 15.

ARTICLE IX


The Board of Directors by a majority vote shall have the power to repeal and amend the By-Laws and to adopt new By-Laws, as well as upon the shareholders, to be exercised by such vote of the directors or of the allotted shares as the case may be; provided, however, not less than a majority thereof as may be fixed by the By-Laws.

2- ARTICLES OF INCORPORATION


ARTICLE X

No contract or other transaction between the Corporation and any other corporation, whether or not a majority of the shares of the capital stock of such other corporation is owned by the Corporation, and no act of the Corporation shall be in any way affected or invalidated by the fact that any of the directors of the Corporation are pecuniarily or otherwise interested in, or are directors or officers of such other corporation; any director individually, or any firm of which such director may be a member, may be a party to, or may be pecuniarily or otherwise interested in, any contract or transaction of the corporation, provided that the fact that he or such firm is so interested shall be disclosed or shall have been known to the Board of Directors, or a majority thereof, and any directory of the Corporation who is also a director or officer of such other Corporation, or who is so interested, may be counted in determining the existence of a quorum at any meeting of the Board of Directors of the Corporation which shall authorize such contract or transaction, with like force and effect as if he were not such director or officer of such other corporation, or not so interested.
