#### ARTICLES OF INCORPORATION

## KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, Robert Benscoter, Richard Barnes, Dorothy Benscoter, George Hill and Arthur Moore, all being of full age and all being citizens of the United States of America, and residents of the State of Idaho, have associated and do hereby associate themselves together, for the purpose of forming a non-profit cooperative association, under Title 30, Chapter 10, Idaho Code, governing non-profit cooperative associations.

I.

The name of this corporation shall be PRIEST LAKE CHAMBER OF COMMERCE, INC.

#### II.

The purposes of this corporation shall be as follows:

- 1. To render civic services through the organized efforts of the business and commercial men and women of the community.
- 2. To promote the welfare of the community and its citizens through active and constructive projects which will benefit the community at large.
- 3. To provide training and leadership and organization for business men and women and to instill in them, a civic consciousness so as to better their usefullness as citizens.
- 4. To meet together and discuss problems and areas of common concern and to formulate courses of collective action to solve the problems of the community.
- 5. To advertize and to promote the pristine beauty and scenic qualities, to gether with the recreational

- 6. To acquire by purchase, gift, lease, devise or bequest and to hold, mortgage and dispose of such property, real or personal, as the above purposes of the corporation shall require, for the benefit of its members, and not for pecuniary profit.
- 7. In the event of a dissolution of the corporation, to transfer any assets or property of the corporation, only to a successor non-profit corporation, to a body politic, or to a religious social benevolent or other type of non-profit corporation.
- 8. To do all things necessary and incidental to and growing out of the above purposes.

III.

The period of the existence and duration of this corporation shall be perpetual.

IV.

The principal place of business and the location and post office address of its registered office shall be Priest Lake, Idaho.

٧.

This corporation shall be non-stock and no dividends or pecuniary profits shall be declared to the members hereof.

VI.

The general officers of the corporation shall consist of a president, vice-president and secretary-treasurer.

VII.

The board of directors shall manage the affairs of the corporation, and shall consist of five members who shall be the officers of the corporation and two other members who shall be elected from the membership of the corporation, and serve as directors.
