Subject: Submission of Articles of Incorporation for CNR Inc.

We, the undersigned, natural persons of the age of 21 years or more, acting as incorporators of a corporation under the laws of the state of Idaho, adopt the following articles of incorporation for such corporation:

ARTICLES OF INCORPORATION

1. Section 30-1-54

- a. The name of the corporation is CNR Inc.
- b. The period of its duration is perpetual.
- c. This corporation is organized to transact any or all lawful business for which corporations may be incorporated under this act.
- d. 500 shares of common stock are to be issued initially, without par value, with a maximum ceiling of 10,000 shares.
- e. The owners of said corporation must be offered the right of first purchase of any shares offered for sale or transfer by any shareholder to any outside party. Only after the sale or transfer of these shares is rejected by the owners may these shares be sold or transferred to an outside party.
- i. The address of the initial registered office is CNR Inc., 5328 Rockney St., Boise, Idaho 83705. Its agents at said address are Richard M. and Cheryl L. Fullilove.
- j. The number of directors constituting the initial board of
