THE UNDERSIGNED, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is Genco Investments, Inc.

SECOND: The period of its duration is perpetual.

THIRD: The purpose for which this corporation is formed shall be the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 1,500 shares of no par value.

FIFTH: Provisions for the regulation of the internal affairs of the corporation are such as may be provided by the By-Laws of the corporation, by agreement of the stockholders, and the provisions of the Idaho Business Corporation Act.
