

ARTICLES OF AMENDMENT

ARTICLE I

SECRETARY OF STATE

Inc.

The name of the Corporation is Idaho Health Care Purchasing,

ARTICLE II

The following amendment to the Articles of Incorporation has been adopted by the sole shareholder of the Corporation:

Article I of the Articles of Incorporation is amended to read in its entirety as follows:

"The name of the Corporation is Central Purchasing of Idaho, Inc."

ARTICLE III

The foregoing amendment was adopted by the sole shareholder on November 5, 1985.

ARTICLE IV

The amendment was approved by the required vote of shareholders in accordance with Section 30-1-59 of the Corporation Laws of the State of Idaho. The total number of outstanding shares entitled to vote with respect to the amendment was 100, of which all voted in favor thereof.


ARTICLE V
