

ARTICLE OF INCORPORATION

OF

NEW HORIZON, INC.

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST:

The name of the corporation is New Horizon, Inc..

SECOND:

The period of its duration is perpetual.

THIRD:

The purpose or purposes for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH:

The aggregate number of shares which the corporation shall have authority to issue is One Thousand (1,000) shares of One Hundred Dollars (\$100.00) par value.

FIFTH:

Provisions denying preemptive rights are: None.

SIXTH:

The address of the initial registered office of the corporation is 1231 West Main Street, Burley, Idaho 83318; and the name of its initial registered agent at such address is Keith Wilson.
