ARTICLES OF INCORPORATION
OF
PARADISE VENTURES, INC.

The undersigned, being a natural person, does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a business corporation pursuant to the provisions of the Idaho Business Corporation Act.

FIRST: The name of this corporation is Paradise Ventures, Inc.

SECOND: The duration of the Corporation shall be perpetual.

THIRD: The purposes for which the Corporation is organized shall be to engage in any lawful business for which corporations may be incorporated under the Idaho Business Corporation Act, other than those businesses where special provision is made by law for the preparation, contents and filing of articles of incorporation of designated classes of corporations.

FOURTH: The aggregate number of shares which the Corporation shall have authority to issue is 1,000 shares, all of which are of a par value of \$1.00 each and are of the same class and are to be Common Capital Stock.

FIFTH: The name of the initial registered agent of this corporation is Brad S. Press. The address of the initial registered office of the corporation is 1038 West "C" street, No. B, Moscow, Idaho 83843.

SIXTH: The number of directors constituting the initial Board of Directors of the corporation is one (1), and the name and address of the person who is to serve as director until the first annual meeting of shareholders or until his successor is elected and qualify is:

SEVENTH: The name and address of the incorporator is Brad S. Press, 1038 West "C" Street, No. B, Moscow, Idaho 83843.

EIGHTH: The corporation elects to have preemptive rights to the fullest extent permissible under the Idaho Business Corporation Act.

NINTH: The liability of the directors of the Corporation for monetary damages shall be eliminated to the fullest extent permissible under the Idaho Business Corporation Act.

TENTH: The Corporation is authorized to indemnify its directors and officers to the fullest extent permissible under the Idaho Business Corporation Act.

ELEVENTH: No shareholder of the Corporation entitled to vote in the election of directors shall be entitled as of right to cumulative voting in any such election.
