The undersigned, for the purpose of forming a Non-Profit Corporation under the laws of the State of Idaho in compliance with the provisions of Title 30, Chapter 3, Idaho Code, does hereby certify, declare, adopt and submit to the Idaho Secretary of State, the following Articles of Incorporation.

ARTICLE I NAME

The name of the Non-Profit Corporation shall be CARRY THE FIRE, INC. (hereinafter, "the Corporation").

ARTICLE II PURPOSE AND POWERS

The Corporation is organized exclusively for charitable purposes, including but not limited to, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code. Notwithstanding any other provision of these articles, the Corporation shall not, except to an insubstantial degree, engage in any activities or exercise any powers that are not in furtherance of the purposes of this Corporation, including, but not limited to, carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. No part of the net earnings of the Corporation shall inure to the benefit of, or be distributable to its directors, members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.

ARTICLE III REGISTERED AGENT

The location and street address of the initial registered office of the Corporation shall be 2368 N. AMETHYST AVE., MERIDIAN, IDAHO 83646, and JEFFREY L. HOSKINS II is hereby appointed to be the initial registered agent of the Corporation.

ARTICLE IX INDEMNIFICATION

Pursuant to Section 30-3-88, Idaho Code, the Corporation shall be and hereby is obligated to indemnify any and all persons who were or are a party or threatened to be made a party to any threatened, pending or completed action, suit or proceeding, whether civil, criminal, administrative or investigative, other than an action by or in the right of the Corporation, by reason of the fact that they are or were a director, member, officer, employee or agent of the Corporation, or are or were serving at the request of the Corporation as a director, member, officer, employee or agent of another corporation, partnership, joint venture, trust or other enterprise, against expenses, including attorneys' fees, judgments, fines and amounts paid in settlement actually and reasonably

incurred by them in connection with such action, suit or proceeding if they acted in good faith and in a manner they reasonably believed to be in or not opposed to the best interests of the Corporation and, with respect to any criminal action or proceeding, had no reasonable cause to believe their conduct was unlawful.
