- b. To lease, own, purchase, and sell equipment and or personal property of all types and nature and to acquire, buy, own, hold, sell, exchange, let or lease personal property within the state of Idaho, or outside the state of Idaho;
- c. To borrow money for the purposes of this corporation, to issue bonds, notes, and debentures and other evidences of indebtedness therefore and to secure the same by mortgage or pledge of personal property, including the income of this corporation, or by mortgage of real property, executed in trust or otherwise. All or any portion of the real or personal property of this corporation may be pledged, mortgaged or hypothecated;
- d. To build any or all buildings, structures, warehouses, or erect the same involved in the said business, and to acquire the same by purchase, lease or other means;

- f. To enter into any contract, co-operative agreement or profit-sharing plan with its officers or employees that this corporation may deem advantageous or expedient, or otherwise to reward or pay such persons for their services as the directors see fit;
- g. To purchase or otherwise acquire, own, hold, mortgage, pledge, sell, assign, transfer, or otherwise dispose of shares of capital stock of this corporation or evidence of indebtedness of every kind or nature created by any corporation or corporations, wherever organized, whether public or private;
- h. To exercise generally the powers generally exercised by business corporations, and particularly the powers provided by the laws of the state of Idaho, in any state of the United States, and throughout the world;
- i. To buy, sell, and deal in all kinds of contracts, notes, bills of sale, mortgages, and other evidences of debt, and the security for the payment of the same, to discount or negotiate notes, bills and other evidence of debt; to buy, sell, own and hold shares of capital stock of other corporations;
