
CERTIFICATE OF INCORPORATION OF

ARTICLES OF INCORPORATION

OF

THE HEARTLAND CORPORATION

I, the undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for this corporation:

I.

The name of this corporation shall be THE HEARTLAND CORPORATION.

II.

The period of existence and duration of the life of this corporation shall be perpetual.

III.

The street and post office address of the initial registered office of this corporation is 1000 West Lake; McCall, Idaho (P. O. Box 4267) 83638 and the name of the initial registered agent at such address is Steven R. Nigro, Sr.

IV.

The object and purpose of this corporation and the nature of its business shall be to conduct a maintenance, management and realty business and the transaction of any or all lawful business incident thereto for which corporations may be incorporated under the Idaho Business Corporation Act. Each of the divisions of this corporation may be managed under a fictitious name, so long as any realty business shall be managed only in accordance with the license and regulation requirements of the Real Estate

Commission.

V.

The total authorized number of shares of this corporation shall be 100, with no stated par value, which shares shall be common stock and shall not be subject to assessment. The initial capitalization of the corporation shall be the value of the office equipment, contracts, expertise, offices and cash contributions of the incorporator.

VI.

The name and post office address of the incorporator is as follows:

VII.

The number of persons to serve on the Board of Directors shall be fixed by the Bylaws of the Corporation.

The following persons are named directors of the corporation to serve until their successors are elected and qualified:

Lynnette Nigro P. O. Box 4267; McCall, Idaho 83638.

VIII.

All or any meetings of the shareholders, or of the Board of Directors may be held within or without the State of Idaho.

IX.

ALL STOCK ISSUED BY THIS CORPORATION SHALL BE SUBJECT TO THE AGREEMENT FOR THE PURCHASE AND SALE OF STOCK SHARES, ON FILE AT THE OFFICE OF THE CORPORATION, AND EACH SHARE ISSUED BY THE CORPORATION SHALL HAVE EVIDENCE OF SUCH AGREEMENT PRINTED ON THE CERTIFICATE EVIDENCING SUCH SHARE. SAID AGREEMENT PROVIDES FOR THE FIRST OPTION FOR THE SALE OF ALL SHARES OF THE CORPORATION TO BE HELD BY THE INITIAL SHAREHOLDERS.

X.

THE MANAGEMENT OF THE AFFAIRS OF THE CORPORATION SHALL BE BY THE BOARD OF DIRECTORS, AND AS SET FORTH IN THE BY-LAWS TO BE ADOPTED HERAFTER.

XI.

THE BOARD OF DIRECTORS OF THE CORPORATION MAY, FROM TIME TO TIME, DISTRIBUTE ON A PRO RATA BASIS TO ITS SHAREHOLDERS OUT OF THE CAPITAL SURPLUS OF THE CORPORATION A PORTION OF ITS ASSETS, IN CASH OR PROPERTY.

XII.

THE PRIVATE PROPERTY OF THE SHAREHOLDERS, DIRECTORS, AND OFFICERS SHALL BE FOREVER EXEMPT, SO FAR AS POSSIBLE UNDER IDAHO LAW, FROM THE DEBTS AND OBLIGATIONS OF THE CORPORATION.


