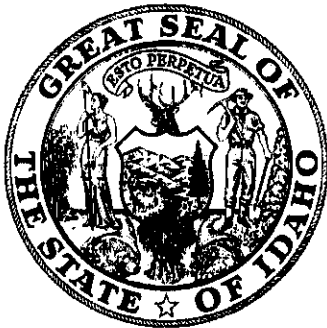

AMENDMENT TO ARTICLES OF INCORPORATION

A special meeting of the shareholders of Greenline, Co., Inc. was held on the 23 day of September, 1991 at the corporation office in Ashton, Idaho.

At the time of the meeting, there were 100,000 shares of capital stock of Greenline Equipment Co., Inc. outstanding. There were present in person or proxy at the meeting held to consider the adoption of the hereinafter amendment to Article IV of the Articles of Incorporation 100,000 shares of capital stock of Greenline Equipment Co., Inc.

The following amendment to the Articles of Incorporation of Greenline, Co., Inc. was proposed:

Article IV shall be adopted to provide as follows:

ARTICLE IV

PURPOSE AND POWERS OF THE CORPORATION

The specific purpose for which this corporation is formed is to enter into a general merchandising business, buy and sell equipment and repair parts both at retail and wholesale, manufacture and assemble equipment for distribution to the general public, operate wholesale and retail distribution outlets and conduct general commerce in whatever manner is lawful both within the State of Idaho and outside of the State of Idaho.

In furtherance of said purposes this Corporation shall have power to:

(a) perform all of the duties and obligations related to ownership and maintenance of a wholesale and retail equipment outlet business including purchases of equipment, repair and maintain equipment, assemble and resell equipment;

(b) acquire (by gift, purchase, otherwise), own, hold, improve, build upon, operate, maintain, convey, sell, lease, transfer, or otherwise dispose of real or personal property in connection with the affairs of the Corporation;

(c) borrow money, mortgage, pledge, deed in trust, hypothecate any or all of its real or personal property as security for money borrowed or debts incurred but only with the assent by vote or written assent on one-half (1/2) of the shares outstanding;

(d) purchase components for repair and maintenance of equipment, both farm and industrial and to assemble and distribute goods, wares and merchandise of any kind whatsoever;

(e) to have and exercise any and all powers, rights, and privileges which a corporation organized under the General Corporation Laws of the State of Idaho may now or hereafter have or exercise;

(f) to offer on behalf of a reputable life insurance company group credit term life insurance to its customers and to perform such administrative duties in connection with such customers that have an interest in the policy or certificate of term life insurance; to receive and collect commissions from the sale of such term life insurance and do all things requisite to carry out the terms of this amended Article.

After discussion, upon motion made and seconded to adopt the forgoing amendment, 100,000 shares of stock voted in favor of the amendment and 0 shares of stock voted against the amendment.

A majority of the shares of stock outstanding in Greenline Equipment having voted in favor of the foregoing amendment to the Articles of Incorporation of Greenline Equipment Co., Inc., the Articles of Incorporation were duly amended.

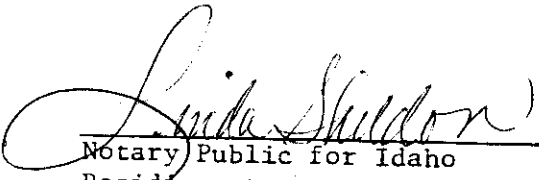
