## Know All Mem By These Presents

That we, the undersigned, all of whom are members of the church of Christ, Boise, Idaho, do hereby associate ourselves together for the purpose of formings religious corporation under the laws of the state of Idaho, In accordance with the provisions of chapter 11, title 30, Idaho Code, and all laws supplemental thereto and amendatory theref, and we do hereby adopt the following articles of incorporation, viz:

### ARITCLE 1

The name of this corporation shall be-25th-Street-Church-ef-Christ
The 25th St. Church of Christ, of Boise, Idaho, Imc.

### ARTICLE III

That the object and purposes for which this corporation is formed, are:

- (a) to establish a church wherein the members of this religious body may meet for worship in the manner prescribed by the New Testament.
- (b) to purchase, lease, or otherwise dispose of real and personal property of every kind, nature, and description, but said corporation shall not own or hold more real estate than is at any time neccessary for the business and objects of corporation.
- (c) to receive donations and to receive, manage, take, and hold real and personal property by gift, grant, demise, or otherwise for the purpose herein specified.
- (d) to do everything necessary, convenient, or proper to be done in carrying out the foregoing enumerated purposes in their fullest and broadest sense without object of profit to the members of said corporation.
- (e) pecuniary profit is not the object of this corporation, The existence of this corporation shall be perpetual.

#### ARTICLE 111

The place where the principle place of business of said corporation shall be located, and its registered office maintained, shall be in the city of Boise county of Ada , state of Idaho.

This corporation is organized without capital stock and no stock of any kind or nature has been or shall he reafter be issued by said corporation.

#### ARTICLE V

That the directors of said corporation shall consist of three (3) members to be elected at the annual meeting of said corporation; provided, however, that said number may be increased to five (5) or more by a two-thirds (2/3) affirmative vote of all members in attendance at any annual meeting voting upon such question.

### ARTICLE VI

That the annual meeting of said corporation for the election of directors and transaction of all other business of said corporation shall be held on the first 1st day of February of each year at the hour of 8:00 o'clock P.M. at the registered office of said corporation in Boise, Idaho; that no notice of the annual meeting shall be required.

### ARTICLE V11

That a meeting of the members of the church of Christ of Boise , Idaho, was duly had and held at the church building at 800N. 25th ST, Boise , Idaho, onthe 16th day of February, 1964 for the purpose of forming this corporation and electing directors thereof; that notice of said meeting was given in the form attached hereto by the posting of a copy thereof in a conspicuous place on the building where such meeting and election was to be held and by publication of said notice for at least two weeks in the Idaho Observor a newspaper of general circulation in and published in the city of Boise , Idaho.

### ARTICLE VIII
