KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, all being citizens of the United States of America, and over the age of 21 years, 5 have this day voluntarily associated ourselves together for the purpose of forming a corporation under and pursuant to the Laws of the State of Idaho, and we do hereby certify:

#### ARTICLE I

Name

The name of this corporation shall be "R & B Market of Caldwell, Inc."

#### ARTICLE II

## Purposes

- To own, purchase, sell, dispose of and deal in or handle at retail or wholesale prices, groceries, produce, meats, foods and food products of 13 all and every kind, together with any other line of merchandise commonly bought and sold incidental to or in anywise connected with the general 14 retail trade in the grocery business.
  - To buy, sell and distribute food products and any other related or incidental products at retail and/or wholesale prices within the State of Idaho and any place outside the State of Idaho, and to do any and all acts necessary and incidental thereto arising out of or in connection with said business.
  - (c) To enter into contracts, agreements or understandings with any person, persons, firms, organizations or corporations for the purchase or sale of food products and merchandise of any nature or kind.
  - To acquire, own, operate, buy, sell, exchange, let or lease, or build buildings, retail stores, wholesale enterprises and warehouses dealing in any of the merchandise referred to expressly or by implication in paragraph (a) above.
  - (e) To acquire, buy, own, hold, sell, exchange, let or lease real estate or personal property within the State of Idaho, or outside the State of Idaho.
  - To borrow money for the purposes of this corporation, to issue (f) bonds, notes and debentures and other evidences of indebtedness therefor, and to secure the same by mortgage or pledge of personal property or real property of the corporation, including the income of said corporation.
  - To purchase, lease or otherwise acquire, in whole or in part, the (g) business, goodwill, rights, franchises and property of every kind, and to take over the whole or any part of the assets or liabilities of any person, firm, association or corporation engaged in or authorized to be conducted by this corporation; to hold or in any manner dispose of the whole or any part of the business or business property so acquired, and to exercise all the powers necessary or incidental to the conduct of such ousiness.
  - To purchase, or otherwise acquire, own, hold, mortgage, pledge, sell, assign, transfer or otherwise dispose of shares of capital stock of this corporation or evidences of indebtedness of any kind or nature created

by any corporation or corporations, wherever organized, whether public or private. 2 To have offices, conduct its business and promote its objects 3 within and without the State of Idaho, in other States, Territories and Colonies of the United States and in foreign countries without restriction as to the place or amount. (j) To exercise generally the powers customarily exercised by business corporations, and particularly the powers provided by the Laws of the 6 State of Idaho, referring especially to Section 30-114 Idaho Code, in any State in the United States and throughout the world. (k) To carry on any other business, or to do anything in connection 8 with the objects and purposes above mentioned that may be necessary or proper to accomplish successfully or promote the said objects and purposes. The foregoing clauses, by reason of the specific enumeration of powers, shall not be held to restrict or limit the powers of the corporation to do 10 any of the things within the purview of its general purposes. 11 ARTICLE III 12 Duration 13 This corporation shall have perpetual existence. 14 ARTICLE IV 15 Place of Business 16 The location and post office address of the registered office of this corporation in this State, and principal place of business shall be Caldwell, Canyon County, Idaho. 18 ARTICLE V Stock 19 That the authorized capital stock of this corporation shall be Fifty 20 Thousand (\$50,000.00) Dollars, divided into Five Thousand (5000) Shares of common capital stock with a par value of Ten (\$10.00) Dollars per share, each share of which said stock shall be entitled to one vote on all matters. 22 | No preference or restrictions are granted to or imposed upon this authorized stock except that said stock shall be non-assessable. 23 ARTICLE VI 24 Directors 25 The corporate powers of this said corporation shall be vested in a Board of Directors, five (5) in number, and such additional or lesser 26 number of directors as may be determined from time to time by the By-Laws 27 of the corporation. 28 ARTICLE VII 29 Incorporators The name and post office address of each of the incorporators of this 30 corporation and the number of shares of common stock subscribed by each, are as follows: 31 32
