

ARTICLES OF INCORPORATION
of the
SLATER CANAL COMPANY, LIMITED.

Know All Men By These Presents: That the undersigned have this day voluntarily associated themselves together for the purpose of forming a Canal Corporation under the laws of the State of Idaho, and do hereby further declare:

First, That the name of said Corporation is, Slater Canal Company Limited.

Second, That the purpose and object for which said Corporation is formed are as follows:

1. The irrigation of lands and town lots in and adjoining Boise City, Idaho for the benefit of the stockholders and members of the Corporation.

2nd The acquisition, ownership, and operation by right of location, purchase or otherwise, of water, water rights, use of water, canals, ditches and ditch rights and laterals, for irrigation of lands and town lots, and all improvements and construction necessary or incident to such acquisition, ownership or operating, and for the benefit of the stockholders and members of the Corporation.

3rd The conveying and transporting of water by means of ditches, flumes, pipes, or any other method, plan or device upon the lands and town lots in or near said Boise City, and the construction of any of such means of water conveyance for the benefit of stockholders and members of the Corporation.

4th The acquisition by purchase or otherwise of any water or water rights, ditches, or lands, and the borrowing of money with or without security, giving notes or other obligations for the payment of money or the securing the payment of money so borrowed, by mortgage or otherwise, guaranteeing the payment of money, and the doing of everything requisite to the full

and complete extinction of a land any of the purposes in these articles mentioned or that they are certain therein.

6th That no water or power of water now owned, leased or controlled in any manner, or that shall hereafter be acquired, owned or leased, or in any way controlled by this Corporation, shall be subject to sale, rental or other disposition for any purpose whatever, to any person other than stockholders or members of the Corporation at the time of such disposition, and that no stockholder or member of the Corporation shall in any way acquire for any purpose a right, title or interest in, or control thereof, except by reason of the ownership of shares of the capital stock of the Corporation.

7th It is hereby especially declared that one of the objects and purposes of the formation of this Corporation is to secure water, the right to the user and control thereof, as a private corporation and for the benefit of the stockholders and members thereof only, and that no water right to user or control thereof, shall in any way be disposed of by said Corporation, excepting to stockholders or members of the Corporation, and that only as the right thereof shall be attached to the stock thereof, as heretofore has been for or that any be hereafter bought or sold, in exchange for water, right to user or control thereof, or other property, ditch or rights, to be a part and parcel of the Canal property of the Corporation.

8th That to each share of the stock of this Corporation shall be inseparably attached the right to the beneficial use of sufficient water to irrigate one acre lot of the dimensions of 25' X 140', and in no case to exceed one-fourth of one inch of water for each share of stock of this Corporation, subject to such adjustment charges and regulations as may be determined from time to time by the Board of Directors.

Third, The place of the principal business of this Corporation shall be transacted in Boise City, Ada County, Idaho.

Fourth That said Corporation shall exist for the term
