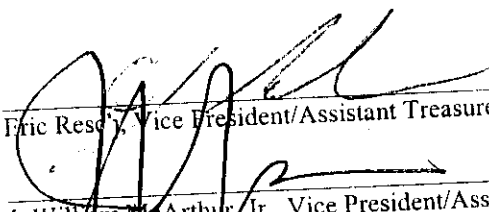
POWER OF ATTORNEY

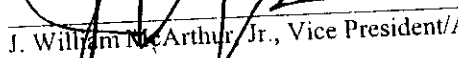
