#### ARTICLES OF INCORPORATION

OF

# BURGESS ENTERPRISES, INC.

KNOW ALL MEN BY THESE PRESENTS: That I, the undersigned, being a natural person of full age and citizens of the United States of America, in order to form a corporation for the purposes hereinafter stated, pursuant to the laws of the State of Idaho, do hereby certify as follows:

## ARTICLE I

The name of the Corporation shall be Burgess Enterprises, Inc.

#### ARTICLE II

The corporation is to have perpetual existence.

#### ARTICLE III

The purposes for which said corporation is formed are:

A. To manage and operate a retail business under a franchise with Sport Shacks, Inc., and to transact any or all lawful business in furtherance of such retail business for which corporations may act under the Idaho Business Corporation Act.

## ARTICLE IV

The capital stock of the Corporation shall be 100 shares of common stock without par value. No shares of the capital stock of the Corporation shall be subject to assessment for any reason.

# ARTICLE V

The address of the Corporation's initial registered office shall be 2500 South Ross, Idaho Falls, Idaho, 83401. The name

of the Corporation's registered agent at that address is David C. Burgess.

### ARTICLE VI

The Board of Directors shall consist of two (2) directors, but during their term of office, or thereafter, the number of directors may be increased or decreased from time to time as may be provided by the By-Laws.

#### ARTICLE VII

The names and addresses of the initial directors to serve until the first annual meeting of the shareholders or until their successors be elected and qualify are as follows:

## ARTICLE VIII

The Board of Directors by a majority vote shall have the power to repeal and amend the By-Laws and to adopt new By-Laws.

## ARTICLE IX

No contract or other transaction between the Corporation and any other corporation, whether or not a majority of the shares of the capital stock of such other corporation is owned by the Corporation, and no act of the Corporation shall be in any way affected or invalidated by the fact that any of the directors of the Corporation are pecuniarily or otherwise interested in, or are directors or officers of such other

corporation; any director individually, or any firm of which such director may be a member, may be a party to, or may be pecuniarily or otherwise interested in, any contract or transaction of the Corporation, provided that the fact that he or such firm is so interested shall be disclosed or shall have been known to the Board of Directors, or a majority thereof, and any director of the Corporation who is also a director or officer of such other corporation, or who is so interested, may be counted in determining the existence of a quorum at any meeting of the Board of Directors of the Corporation which shall authorize such contract or transaction, with like force and effect as if he were no such director or officer of such other corporation, or not so interested.
