



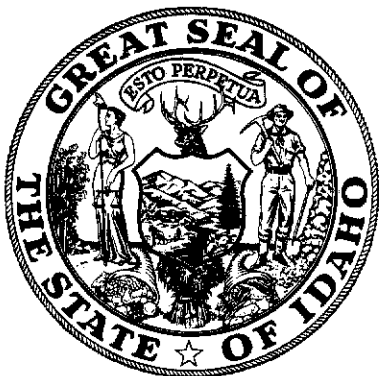
CERTIFICATE OF INCORPORATION

The general nature and purpose of the business of this corpora-
