Articles of Incorporation of

Huguenot Heritage, Inc.

This corporation is organized exclusively for one or more of the purposes as specified in Section 501(c)(3) of the Internal Revenue Code, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code. This Corporation shall be a nonprofit corporation. The specific purposes for which this corporation is organized are:

The purpose of Huguenot Heritage, Inc. is:

- 1. to reach French-speaking people in Latah County and elsewhere with the Gospel of Jesus Christ as it was expressed by the Huguenots in France during the Reformation of the 16th century, with the creation of a French-language Sunday evening worship service as the initial means to this end;
- 2. to minister to Christians from the United States through trips to a study center in France where they will be taught Reformation history and theology, as well as French, the language of original Reformation theological literature; trips will be made from the study center to historical Reformation sites in France and in Switzerland and elsewhere in Europe;
- 3. to translate from English to French or from French to English books which significantly communicate the truths of the Christian life and the Reformed faith;
- 4. to host retreats in France or in the United States to minister Reformational truths to French people in general and to French pastors in particular, in a setting where they can rest and receive biblical teaching and counseling;
- 5. to encourage the planting of churches with the goal of reaching the people of France with the Gospel as it was expressed in the Reformation of the 16th century.

Upon the dissolution of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of this corporation shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes

No substantial part of the activities of this corporation shall consist of carrying on propaganda, or otherwise attempting to influence legislation (except as otherwise provided by Section 501(h) of the Internal Revenue Code), and this corporation shall not participate in, or intervene in (including the publishing or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.

No part of the net earnings of this corporation shall inure to the benefit of, or be distributable to, its members, directors, officers, or other private persons, except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in these articles.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

All references to sections of the Internal Revenue Code shall include such sections as of the date hereof and the corresponding section of any future federal tax code.
