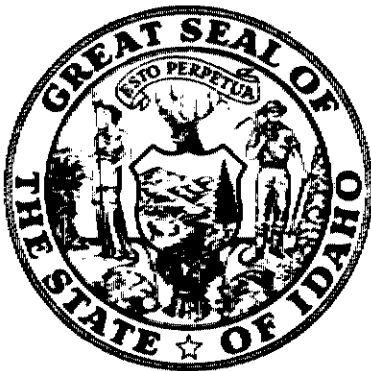

distributed among the shareholders in proportions to their respective rights and interests.






