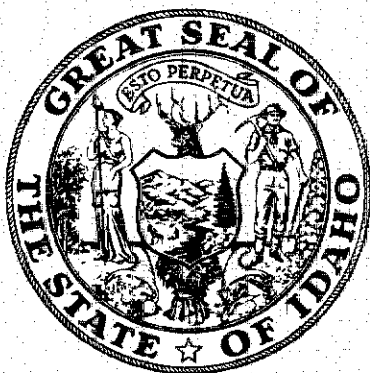

to the
ARTICLES OF INCORPORATION

Pursuant to the provisions of of the Idaho Professional Service Corporation Act, the undersigned corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the corporation is Grefenson, Nicholson & Maxwell, P.A.

SECOND: The following amendment of the Articles of Incorporation was adopted by the shareholders of the corporation on January 2, 1984 in the manner prescribed by the Idaho Business Corporation Act:

The name of the corporation is hereby changed from "Grefenson, Nicholson & Maxwell, P.A." to "Magic Valley Ear, Nose & Throat Associates, P.A."

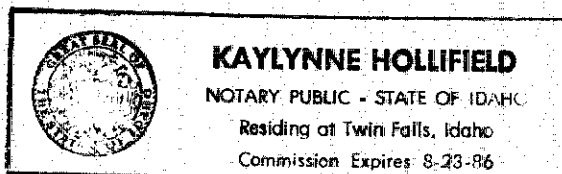
