

ARTICLES OF INCORPORATION OF THE
SETTLERS RESERVOIR & CANAL COMPANY, LIMITED.

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned, have this day voluntarily associated ourselves for the purpose of forming a corporation under the laws of the STATE OF IDAHO, and we hereby certify:

first. that the name of said corporation is THE SETTLERS RESERVOIR & CANAL COMPANY, LIMITED.

second. that the purposes for which this corporation is formed are: to construct, purchase, lease, file upon, operate and maintain reservoirs for the storage of water for irrigation, power and domestic purposes; to buy, sell, file upon and lease water and water rights, rights-of-way, reservoirs, canals, flumes, dams and ditches; to construct, purchase, lease, file upon, operate and maintain reservoirs, reservoir sites, dams, dam sites, flumes, canals and ditches; to construct, purchase, lease, operate and maintain power plants of all kinds, and to sell, lease and rent power therefrom for any and all purposes; to buy, sell, rent and lease land and buildings, rights-of-way, reservoirs, flumes and canals and to mortgage the same; to build, maintain, purchase, flumes, dams and such other pieces of construction, including buildings as may be necessary to operate and maintain a reservoir and canal system; to do any and all things in connection with the filing upon of reservoirs, rights-of-way, dams, canals, ditches and rights-of-way therefor as directed by the laws of the united states and of the state of Idaho, governing such construction, maintenance, and operation upon public lands and waters of the united states and of the State of Idaho. To do any and all things set forth in this certificate as objects, purposes, powers, or otherwise to the same extent and as fully as any individual might do and could do under the laws of the state of Idaho.

third. that the place where its principal business is to

be transacted shall be the village of ghoshone, in the County of Lincoln, state of Idaho.

Fourth. That the term for which it is to exist is Fifty years from and after the date of its incorporation.

Fifth. That the number of its directors shall be five, and that the names and residences of those who are appointed for the first year are:

Sixth. That the amount of the capital stock of this corporation is twenty five thousand (\$25,000.00) dollars, divided into twenty five hundred shares of the par value of ten (\$10.00) Dollars each.
