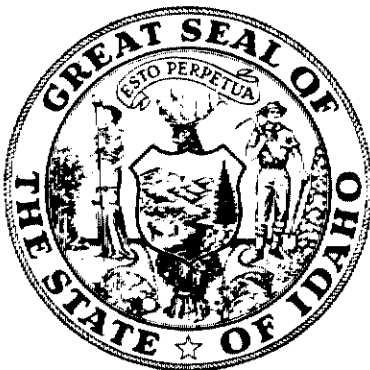

There are no suits pending against RIBS EXPRESS, INC. in any court.


This dissolution has received the unanimous written consent of the shareholders.


Kevin L. Smalley and Florence O. Smalley certify that:

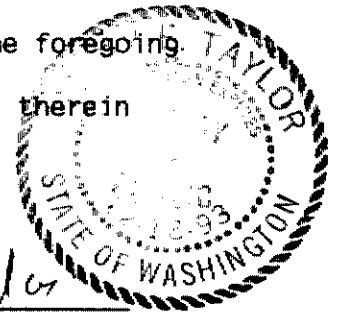
