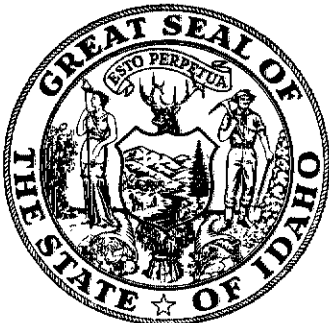

**ARTICLES OF INCORPORATION  
OF  
O.S., INC.**

The undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation of such corporation.

**FIRST**

The name of the corporation is: **O.S., INC.**

**SECOND**

The period of its duration is perpetual.

**THIRD**

The purpose or purposes for which the corporation is organized is to conduct sale of real estate and related operations and to do all acts and exercise all powers, rights and responsibilities available to corporations under the laws of the State of Idaho.

**FOURTH**

The aggregate number of shares which the corporation shall have authority to issue is 100,000 shares of common stock with no par value. Said stock shall be subject to transfer restrictions of first right of refusal as set forth in the by-laws of the Corporation. Any shareholder must be a realtor with a valid realtor's license issued by the state of Idaho.
