## ARTICLES OF INCORPORATION

KNOW ALL MEN BY THESE PRESENTS, That we, the undersigned, being natural persons of full age and citizens of the United States, in order to form a corporation for the purposes herein-after stated, pursuant to the Business Corporation Act of Idaho, do hereby certify as follows:

### I.

That the name of the corporation is: DESERT SECURITIES, INC.

### II.

That the purposes for which said corporation is formed are:

To transact the business of investing on behalf of itself or others, any part of its capital and such additional funds as it may obtain, or any interest therein, and selling or otherwise disposing of the same, or any part thereof, or interest therein;

To engage in the business of the accumulation of money, by lending the capital of the company and such other funds as it may from time to time lawfully acquire from various borrowers upon such personal security or security of personal property as may be agreed upon between the corporation and the borrowers, and by re-lending in like manner the funds arising from such loans when paid;

To act as general contractors for the construction, repairing and remodeling of buildings of all kinds, and for the improvement of real estate, and the doing of any and all other business and contracting incidental thereto, or connected therewith, and the doing and performing of any and all acts or things necessary, proper, or convenient for or incidental to the furtherance or the carrying out of said purposes;

To do all and everything necessary, suitable, and proper for the accomplishment of any of the purposes or the attainment of any of the objects or the furtherance of any of the powers hereinbefore set forth, either alone or in association with other corporations, firms, or individuals, and to do every other act or acts, thing or things incidental or appurtenant to or growing out of or connected with the aforesaid objects or purposes or any part or parts thereof, provided the same be not inconsistent with the laws under which this corporation is organized; and

To extend necessary credit and to perform all other acts incidental hereto, such as acquiring, owning, holding, leasing, selling, exchanging, assigning, mortgaging or otherwise disposing of either real or personal property.

### III.

That the term for which said corporation is to exist is indefinite and, hence, perpetual existence is designated hereby.

### IV.

That the location and post-office address of the principal and registered office is the Carlson Building, City of Pocatello, County of Bannock, and the State of Idaho.

### V.

That the amount of capital stock of said corporation is Twenty-Five Thousand Dollars (\$25,000.00), consisting of two hund-

red and fifty (250) shares of Capital Stock of the par value of one hundred dollars (\$100.00) per share, and the entire voting stock of this corporation shall be divided into equal two hundred and fifty (250) shares.

VII.

That the amount of Capital Stock of said corporation which has actually been subscribed is eighteen (18) shares of Capital Stock.

VIII.






That the number of directors of said corporation shall be not less than three, the number to be determined by the stockholders or directors of said corporation from time to time.
